General Terms of Service and Restrictions on Use of Materials.

If you do not comply with the User Agreement at any time, Fidelity Bank reserves the right to terminate your account and your access to Online Banking.

Fidelity Bank may discontinue or alter any aspect of our Online Banking, including, but not limited to:

- (i) Restricting the time Fidelity Online Banking is available,
- (ii) Restricting the amount of use, and
- (iii) Restricting or terminating any user's right to use Online Banking, at Fidelity Bank's sole discretion and without prior notice or liability. You are responsible for all charges associated with connecting to Fidelity Online Banking.

You are also responsible for obtaining or providing all access lines, mobile phone and computer equipment (including modem) or other devices, necessary to connect to Fidelity Online Banking

Account Password, and Security.

To open an Online Banking account, you must complete the registration process by providing us with current, complete and accurate information as prompted by the registration process. You may be required to choose a password and an Online Banking username. You are entirely responsible for maintaining the confidentiality of your password, token and account. Furthermore, you are entirely responsible for any and all activities that occur under your account.

You agree to notify Fidelity Bank immediately of any unauthorized use of your account or other breach of security. If you elect to register to use Fidelity Online Banking you agree to: (a) provide true, accurate, current and complete information about yourself as prompted by Fidelity Online Banking registration form (such information being the "Registration Data") and (b) maintain and promptly update the Registration data to keep it accurate. If you provide any information that is untrue, inaccurate or incomplete or Fidelity Bank have reasonable grounds to suspect that such is the case, Fidelity Bank has the right to suspend or terminate your account without notice to you and refuse any and all current or future use of Fidelity Online Banking (or any portion thereof).

Customer's responsibility:

The customer undertakes to be absolutely responsible for

- Safeguarding his/her username, passcode, token and/or password, and under no circumstance shall the customer disclose any or all of these to any person.
