RE: APPROVAL OF FIDELITY BANK PLC'S AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2024

In compliance with the Rule Book and post-listing requirements of The Nigerian Exchange Limited ("NGX" or "the Exchange"), Fidelity Bank Plc ("the Bank") hereby notifies the NGX and our esteemed shareholders that on March 4, 2025, the Board of Directors considered and approved the Bank's Audited Financial Statements ("AFS") for the year ended December 31, 2024.
